Notice regarding the status of repurchase of its own shares (repurchase of shares of the Company's own stock in accordance with the provisions of articles of incorporation pursuant to article 459, paragraph 1 of the Companies Act)

Kawasaki, Japan, September 2, 2026 – Fujitsu Limited (“the Company”) today announced the status of repurchase of its own shares, pursuant to the provisions of article 459, paragraph 1 of the Companies Act, as well as the Company's Articles of Incorporation, which was approved at the meeting of its Board of Directors held on April 28, 2026, as follows:

(1) Type of Shares Repurchased:	Common stock
(2) Total Number of Shares Repurchased:	2,397,200 shares
(3) Aggregate Value of Shares Repurchased:	JPY 8,844,032,800
(4) Repurchase Period:	August 1, 2026 – August 31, 2026
(5) Repurchase Method:	Purchase by means of market trades on the Tokyo Stock Exchange

1. Details of Matters Concerning the Purchase (as announced on April 28, 2026):

(1) Type of Shares to be Repurchased:	Common stock
(2) Total Number of Shares to be Repurchased:	100,000,000 shares (maximum limit) (Ratio of the total number of issued and outstanding shares [excluding treasury stock]: 5.76%)
(3) Aggregate Value of Repurchases:	JPY 150 billion (maximum limit)
(4) Repurchase Period:	May 1, 2026 - March 31, 2027
(5) Repurchase Method:	Purchase by means of market trades on the Tokyo Stock Exchange (including purchases by means of market trades based on a discretionary investment contract with securities firms and through share repurchases made outside of trading hours [ToSTNet-3])
